| EuRIC's EU policy monitoring



The Council has published a partial **compromise text** on the European Commission's proposal on circularity requirements for vehicle design and on end-of-life (ELVs) vehicles' management. Read the Hungarian Presidency's partial compromise text **here**.

In April, MEP Ondřej Kovařík (Renew Europe, Czechia) **asked** the European Commission to explain why the definition of recycled plastic under the End-of-Life Vehicles Regulation differed from the findings of the 2023 Joint Research Center Study on recycled plastic. Kovařík argued that the ELVR definition poses significant challenges to the regulation's efficacy, as it includes materials like elastomers, thermosets, and process materials such as paints, adhesives, and sealants—typically deemed non-recyclable or difficult to recycle according to JRC findings. In mid-July, Virginijus Sinkevičius, the EU Commissioner for Environment, Ocean, and Fisheries, **responded** that the proposed recycling targets align with plastics identified as recyclable in both the JRC study and the regulation's impact assessment.



Ecodesign


The European Commission has published an article on the Ecodesign for Sustainable Products Regulation (ESPR), the new EU law on sustainability requirements for a wide range of everyday household products that entered into force last week. "To make sure everyone knows what to expect, and that companies have enough time to prepare, the Commission will publish multiannual working plans, listing the products and measures to be addressed. Noting that the first working plan will be adopted within 9 months, the Commission also highlights that **ESPR, in addition to energy-related products, is likely to include highly impactful products, such as clothes, furniture, steel, aluminium, tyres, and ICT products.** Read the article [here](#).



Net-Zero

The revised Industrial Emissions Directive (IED) has been **published** in the EU's Official Journal and entered into force on 5 August. Following that date, EU member states will have up to 22 months to incorporate the provisions of the directive into their national legislation.

The IED is the main EU instrument regulating pollutant emissions from industry. The new rules will offer better protection of human health and the environment by reducing harmful emissions from industrial installations, while promoting energy efficiency, a circular economy and decarbonisation.

 Timeline: On 5 April 2022, the European Commission proposed a revision of Directive 2010/75/EU, the so-called IED. After the Council and Parliament adopted their positions in March and July 2023, correspondingly, a provisional agreement was reached on 29 November 2023. The agreement was formally adopted by Parliament on 12 March 2024 and by the Council on 12 April 2024, while the final act was signed on 24 April 2024.



Construction & Demolition

In its Manifesto, to be **published** on August 5, EuRIC's Construction and Demolition Branch presents 5 five key policy recommendations for the EU's next five-year mandate (2024–2029) to increase circularity in the construction sector.



Waste Shipments

- The European Commission has adopted a delegated regulation under the Waste Shipments Regulation on certifying interim and non-interim recovery and disposal operations. This act introduces a certificate template for facilities performing interim waste treatment, confirming subsequent treatment completion at another facility. The information will be provided via an electronic system when waste is shipped for further treatment.

The European Parliament and Council are reviewing this act until 19 September. If no objections are raised, it will be adopted. You can access the adopted act [here](#).

- The Commission is expected to present a Report on the effectiveness of the WSR in addressing the management of plastic waste, not earlier than 21 May 2029. The expected Report, which is required by Article 73(5) of Regulation (EU) 2024/1157, would assess the implementation of the provisions addressing the management of plastic waste and would provide information on the evolution of the capacity of waste operators in the field of plastic waste management. Furthermore, if deemed necessary, the Report could be accompanied by a legislative proposal amending the Waste Shipment Regulation which could include stricter conditions on the export of plastic waste to third countries.



E-waste

The European Commission has proposed enshrining the Basel Convention provisions into EU law. This means that every e-waste shipment, regardless of whether the waste is hazardous or not, must follow the prior notification procedure. Mandating a prior notification procedure for all e-waste shipments, irrespective of hazard classification, means more administrative burden, potential delays in shipments, higher operational costs for recyclers, and a barrier to efficient resource reuse and recycling.

EuRIC has issued a **joint position paper with Eurometaux**, challenging the Commission's move.



Other EU files

Green Claims Directive:

The Council of the European Union has published a [note](#) on the outcome of European Parliament's first reading on the Green Claims Directive. With the Council having adopted its position (general approach) on 17 June, trilogues are now ready to begin with the EP.

Environmental Crime Directive:

In late July, the Hungarian Presidency presented the Council's [conclusions](#) on combating cross-border environmental crime at the Law Enforcement Working Party (LEWP)-Police. Among others, the conclusions urge Member-States to timely transpose the new Environmental Crime Directive.



Hungarian Presidency

EU Internal Market and Industry Ministers met in Hungary on 8-9 July to discuss the Hungarian Presidency's goal to establish a European Competitiveness Deal. This initiative, inspired by the Antwerp Declaration for a European Industrial Deal and Enrico Letta's report "Much More Than a Market," aims to create a robust framework for EU policies from 2024 to 2029, steering the implementation of the new Strategic Agenda.

Key topics at the informal Compet meeting included the rise of the electric vehicle industry, essential elements of the new competitiveness deal, and the impacts of artificial intelligence on competitiveness. Read more [here](#).

Ursula von der Leyen has secured a second term as President of the European Commission. Ahead of the vote in the European Parliament plenary on whether to re-elect her, the Political Guidelines for the next Commission (2024-2029) have been [published](#). Achieving a more circular and resilient economy holds a prominent spot among the priorities! The incumbent European Commission President plans to introduce a

new Circular Economy Act, aiming to "create market demand for secondary materials and a single market for waste, notably in relation to critical raw materials." "Working to decarbonise our economy will be part of our continued shift to a more sustainable pattern of production and consumption, retaining the value of resources in our economy for longer," von der Leyen states. In early July, EuRIC visited the Remondis site in Eindhoven, which processes 600,000 tonnes of waste a year and sort it into 22 fractions. The visit also joined Roger Versluis - Regional Director (Remondis), Tijn de Jong – Project Manager in charge of sustainability (Remondis), Unico van Kooten – DWMA, Japanese delegation – Japan's Industrial Waste Information Centre.



Visit of Stora Enso site in Langerbrugge

At Stora Enso's Langerbrugge site, Philippe Doliger, EuRIC's Policy Advisor, alongside our Belgian member, Denuo, explored circularity in paper and cardboard waste management. Each year, 400,000 tons of household paper and cardboard are sorted, with some recycled into newsprint on-site, demonstrating effective loop-closing.
