## Report No.15 June 7 2021

China: Important import policy adjustment: Imported recycled steel, brass, copper and cast aluminum alloy raw materials must be subjected to inspection as from June 10 2021

General Administration of Customs Announcement No. 39 of 2021 (Announcement on Adjusting the Catalog of Import and Export Commodities Subject to Inspection)

According to the "Law of the People's Republic of China on Import and Export Commodity Inspection" and its implementation regulations, the General Administration of Customs has decided to adjust the catalog of import and export commodities that must be inspected. The announcement is as follows:

- 1. 234 10-digit customs commodity codes involving mechanical and electrical products, metal materials, chemicals, and artificial jewelry have been removed from the supervision condition "A", and the customs will no longer implement imported commodity inspections on related commodities.
- 2. The supervision condition "A" is added to the eight 10-digit customs commodity codes involving imported recycled raw materials, and the customs conducts import commodity inspections on related commodities.
- 3. The customs supervision condition "B" is added to 24 10-digit customs commodity codes involving exported billets and pig iron, and the customs conducts export commodity inspections on related commodities.

This announcement will be implemented on June 10, 2021. See the attachment for the adjusted regulatory requirements.

- 二、对涉及进口再生原料的8个10位海关商品编号增设监管条件"A",海 关对相关商品实施进口商品检验。
