Four Leading Associations Team Up to Tackle the EU's Waste Legislation Implementation Gap

On 1 March, **FEAD**, **EURIC**, **MWE**, **and CEWEP**, four of the most prominent associations in the waste management and recycling sector, joined forces and held a dinner debate with policymakers to address the gap in the implementation of the EU's waste legislation.
