### Von der Leyen talks raw materials, Ukraine in Canada, US

DW: With the fallout of the war in Ukraine felt across the European Union, the bloc is racing to end fossil fuel reliance on Moscow and ramp up production of homegrown renewable energy. But that will require more access to critical minerals and raw materials like lithium, cobalt, or rare earth metals – and that is where Washington and Ottawa could come in.



# Denmark inaugurates world's first crossborder CO2 storage site

EURACTIV: The opening marks an important moment for the EU's green transition and industrial competitiveness, according to European Commission President Ursula von der Leyen, who spoke at the inauguration on Wednesday (8 March).

Project Greensand is the first venture to achieve cross-border carbon capture and storage (CCS), by shipping CO2 from Belgium and injecting it into a depleted oil field under the Danish North Sea.



## G-7 eyes joint effort to turn e-waste into rare earths, other metals

Nikkei Asia: During a trip to Washington in January, Yasutoshi Nishimura, Japan's minister for economy, trade and industry, called for a new "network" for recycling rare metals with U.S. and Europe. Japan aims to set up a working group to promote cooperation on extracting the materials when it hosts the G-7 summit in May.
