In a surprising twist, Belgium's Prime Minister Alexander De Croo has taken a stand against the prevailing de-growth concept that dominated discussions in the European Parliament. Urging for a shift in focus, De Croo emphasised the need to prioritise "what truly matters" amidst the clamor to address multiple issues simultaneously. By echoing French President Emmanuel Macron's plea for a regulatory pause, De Croo has further intensified the discourse. However, his stance has also resulted in a divided nation, highlighting the contrasting views and opinions within Belgium.

The green technology expoEcomondo: Call for Papers

The call for papers for this years Ecomondo is officially open. Interested parties can submit an abstract on a core theme of the Expo on the website. Until 30 June 2023, it is possible to <u>submit an abstract</u> dedicated to a research project, best practice or successful experience and be included as a speaker in the conference programme of Ecomondo 2023.

This year's trade fair and expo will host more than 100 conferences and workshops on innovation best practices, policy and regulatory issues, research and innovation priorities and funding opportunities, entrepreneurship, international networking and partnership creation, financing, education and communication in the Green and Circular Economy and Green Deal sectors.

The core topics of Ecomondo

A number of the conferences are open to contributions from delegates, representatives and researchers from the public and private sectors, regulators and society, who will be able to integrate the contributions of invited experts with their own experiences, views and best practices from different sectors and countries. The Ecomondo 2023 Call for Papers is linked to the core themes of the exhibition: waste treatment and resource recovery, water cycle and blue economy, industrial symbiosis for the circular economy, energy from forests, indoor air quality and odour emissions, sustainable strategies for the remediation of polluted sites.

Ecomondo will take place from 7-10 November 2023 in Rimini, Italy.







CEDEFOP Circular Economy Policy Brief

The linear 'take, make, waste' model, which took hold with the first industrial revolution and has powered economic development around the globe since then, has an enormous environmental and carbon footprint. Resource extraction, processing of materials and fuels, and food production account for an estimated 50% of greenhouse gas (GHG) emissions and are responsible for 90% of biodiver (sit loss and water stress (situations where water resources in a country or region do not meet needs) (European Commission, 2019). COVID-19 and the energy crisis that followed the invalision of Ukraine have disrupted supply chains. Crises can facilitate the transition to circularity. From a corporate perspective, adopting circular practices in times of crisis can become a risk mitigation strategy (i.e. real reasons for becoming circular). Soaring energy prices and increasing awareness of the fragility of global supply chains can incentivise businesses to adopt circularity practices to maintain competitiveness and to secure stable supply of materials

Birmingham to become UK's first centre for rare earth magnet recycling

Recycling Magazine: Rare earth recycling company HyProMag, which was formed by researchers from the University of Birmingham's School of Metallurgy and Materials, is to be acquired by Maginito. HyProMag's core technology is the based upon the patented process – Hydrogen Processing of Magnet Scrap (HPMS), which was originally developed within the University's Magnetic Materials Group (MMG) to extract rare earth magnets from scrap and redundant equipment and subsequently licensed to HyProMag.



Czech government lays out plans for DRS

EUWID: The Czech Ministry of the Environment unveiled plans for the implementation of a mandatory deposit return system (DRS) for PET bottles and drinks cans on Tuesday. The ministry intends to present an amendment to the Act on Packaging by the end of this year. If the legislation is approved, the deposit return system (DRS) could be operational by mid-2025.



ENDS Europe Interview: ECHA's new director on reform of EU chemicals regulations

The European Commission is currently finalising a proposal to reform the EU's flagship chemicals legislation, the REACH Regulation, in the context of the CSS. But large parts of the European chemicals industry have been unequivocal in their assertion that the reform is unnecessary. "I think from an industry perspective, it's always about the certainty and the predictability of legislation," McGuinness says. "You can understand from an industry perspective, and notwithstanding any other comments around about whether REACH is working or not, they've known it for 15, 16 years, so they're familiar with it."
